#### 1.0 PURPOSE

**1.1** The purpose of this report is to advise the board of the financial position and key performance areas for the Trust for period ended 25<sup>th</sup> December 2022. (Quarter 3)

## 2.0 SERVICE OVERVIEW

#### 2.1 Libraries

#### 2.1.1 Visits in person and digital visits to Libraries

Visits in person are at 66% of pre-covid levels, which is a significant improvement on Q2, but continues to be a much slower return than anticipated when setting targets for this year. As anticipated, digital usage is slightly down on last year as people are substituting virtual access for physical access.

Physical and virtual attendance was stronger in period 9. This follows the launch of the digital newsletter publicising the services and activities available in libraries.

## 2.1.2 Festival of Facts October 2022

A programme of events was targeted at encouraging young people to make a physical return to libraries. The Children & Families team took the theme of exploring libraries' non-fiction resources for 5-8 year olds. Over 350 people attended events across two community venues and five libraries.

The service engaged Eureka Arts Edinburgh to bring their 'Curiosity Cart' making gummy worms and rockets. The team also commissioned author Alom Shaha to create a unique short film illustrating one of the science projects from his book 'Mr Shaha's Marvellous Machines'. Branch activities included dressing up sessions and football quizzes.

#### 2.1.3 Book Week Scotland November 2022

Adult Services developed a programme of free, in-branch, activities for Book Week Scotland celebrating the work of local authors, which included a writing workshop at Milngavie Library and a talk on local footballing heritage in Bishopbriggs Library. Budding bakers enjoyed an evening of cakes and chat with at William Patrick Library and popular crime author Allan Martin launched his latest book "Tales Murderous" at Bearsden library. Craighead and Lennoxtown libraries hosted 'Brew and a Blether' events.

Children & Families focused on encouraging school visits with the theme of Scotland's stories, as part of the Year of Storytelling. The Service had class visits from one nursery and 7 schools - with Hillhead Primary and Craighead Primary managing to bring the entire school across the week.

## 2.1.4 Digital Newsletter

The end of October saw the first edition of a digital East Dunbartonshire Libraries newsletter. The newsletter is a pilot for the trust, designed to be an engaging and light touch read, sharing information about core services, activities and books. The newsletter links to web pages which provide more detailed information on the full range of library services. This allows users to have a general awareness of the breadth of services, and to choose which areas are of particular interest (eg details of BookBug sessions). It also ensures the newsletter is pleasant to read and easy to download on a wide variety of devices. Sign up to the newsletter is by web-link, and is advertised on QR-code enabled posters.

## 2.2 Heritage & Arts

#### 2.2.1 Visits in person and digital visits to museums

Visits in person for Q3 are at 72% of pre-covid levels, which is a significant improvement on Q2, which achieved only 41% of pre-covid visits, but is only 83% of the Q3 target.

Digital usage continues to be strong, with period 9 achieving 38% above target, although overall the digital usage for the quarter was slightly under target at 96%. The combined visits in person and digital usage figures shows the service achieving.

The combined visits in person and digital usage figures shows the service achieving 91% of the overall target for the quarter.

## 2.2.2. Exhibitions

The popular Christmas Art & Craft exhibitions opened at the Auld Kirk Museum on Saturday 5th November with over 150 visitors attending, and over 200 visitors attending the opening event at the Lillie Art Gallery on 12th November.

#### 2.2.3 Arts and Events

The Saturday smART art classes made a welcome return to the Lillie Art Gallery, with a phased return from November onwards.

#### 2.2.4 Archives and Local Studies

Visitor figures increased in Period 9 to 1,053 from 849 in Period 6 and 828 in Period 7. Five volunteers contributed 105 hours in Q3 - adding value by helping to make collections more accessible to the public through indexing and transcribing.

#### 2.2.5 Online Collections Discovery Tool

Made possible from earlier funding from Museums Galleries Scotland, the redesigned Heritage & Arts online collections catalogue went live, with a new URL https://collections.edlc.co.uk/

The public can use this to search the museum/gallery and archives collections and also 5,000 local studies photos. Digital images of many of the collections are already available and more will gradually be added over time. The redesign has focused on making the collections discovery tool more user friendly and engaging. The site has responsive design so adapts to any device. In addition the collection descriptions will also show up in search engine results making them more discoverable and accessible.

#### 2.2.6 Kirkintilloch Town Hall

While the venue continues to operate as a vaccination clinic and is not generally open to the public or available for other hires, the service worked with Your Kirky, Kirkintilloch Community Council, to accommodate a community cinema event, which took place on December 17th, attracting over 250 audience members.

## 2.3 Active Schools

## 2.3.1 Active Schools – Term 1 2022-23 (August- December)

This term the Active Schools team have been working to re-establish core extracurricular activity across East Dunbartonshire schools, with the long term aim to build back to the levels of activity seen pre-pandemic. The first step in this process is to begin to gather full data on extra curricular activity levels in each school, something which has not been possible since before the pandemic.

The team completed this process at the start of January 2023, and are awaiting for sportscotland to publish the complete analysis. The following information can be reported prior to the official statistics being released:

- There were 1,725 male and 1,405 female distinct participants in extracurricular sport and physical activity across all East Dunbartonshire schools.
- 245 people delivered extracurricular sport, 226 of which were volunteers.
- Of the total deliverers 94 were young leaders (14+ secondary pupils) who delivered activity across the local authority.
- 29 schools (primary, secondary and ASN) had direct input from one or more local sports clubs during term 1.

# Sportscotland Inclusion Project Investment (Formerly Program For Government)

In December, due to budgetary pressures, the Scottish Government withdraw their £33 million commitment to Sportscotland for the 'Inclusion Projects' Investment. East Dunbartonshire's Active Schools Team had three projects at various stages of the funding process; with one that had been approved in June 2022, one that was waiting resubmission in December 2022, and one going through its first round of the application process.

The Scottish Government and Sportscotland have upheld their commitment to those projects that had been approved at the first round of applications in June 2022. This means the Active Schools 'Inclusive Dance' project will continue to be funded in its entirety. The Active Schools team is working with sportscotland and Research Scotland to evaluate this project and an update will be provided to the EDLCT Board.

All other projects that had not had final approval will not be progressed, however there is a commitment to reconsider these bids if the investment is reinstated.


#### East Dunbartonshire Council and Sportscotland Partnership Agreement 2023-27

The Partnership Agreement is a commitment between East Dunbartonshire Council, EDLCT and sportscotland to identify, plan and deliver shared priorities for sport and physical activity, and to secure an in-principle commitment to resources and working together over the period April 2023 – 31 March 2024. The agreement has been drafted and awaiting confirmation from EDC. It will be submitted to Sportscotland by 31st January 2023, and presented to their Board thereafter.

#### 2.4 Sports Development.

#### 2.4.1 Overview of Progress.

Term time classes continued to increase slightly from the last quarter. The diagram below shows the number of members attending weekly classes at leisure centres in December 2022:



Our 40 week term time programme finished mid-December for 3 weeks over the holiday period and as this is the only time of the year where Sports Development do not offer any holiday classes, the majority of staff used up their annual leave to take an extended break.

#### Key Achievements / Areas of Focus

- Football primary schools programmes are going well and due to the positive response from children during sessions, the coaches have been invited to deliver some reading sessions to the children at Hillhead Primary School
- There was a mix of good news and bad news over the October holidays. There was little uptake on the Sports Camps resulting in their cancellation however the Swimming Camps were all full and many children who attended were then placed on term time lessons which in turn reduced the waiting lists.
- The local heats of the Scottish Schools Swimming Gala were held at the Leisuredrome on the 5th November for the first time since returning from covid restrictions. Entries were lower than previous years with 84 pupils taking part, this enabled the heats to take place in the afternoon which allowed the swimming lessons to run in the morning as normal.

#### 2.4.2 Areas requiring Improvement

- There is a potential longer term solution for a better, online booking process for holiday programmes as well as improving the functionality of OnCourse for term time bookings. Initial investigation work is being carried out with the supplier.
- Hand held devices are not yet operational for coaches to record attendance at all classes and progress through the Learn to Swim (LTS) levels – ICT are working to complete the set up on tablets following configuration problems but were delayed in December due to other priorities.
- The LTS waiting is list is down slightly from last quarter to around 500 across East Dunbartonshire. The aim is to reduce this further when the Allander opens early next year and then again during Easter. The team are reviewing timetables in January along with facility availability and staffing levels to increase the number of spaces available in lessons.

## 2.5 Leisure Centres

#### Mobile App

The number of customers signing up to the mobile app continues to demonstrate a steady growth:

We are currently working with developers to improve the customer experience with API integration in the Advantage booking system. This is due to be integrated before the new Allander Leisure Centre opens.

#### Online Booking System

Our online booking system has 17,802 customers sign up.

There have been some subtle changes to the book ahead policy at the end of Period 9. All members' bookings can book a full 7 days in advance. Previously we could not bring the same front of house and online booking terms and conditions together. However, updates to the online booking system has integrated the systems and takes away the possibility of user error at reception.

This has now put more pressure on the booking system at 7am when the following weeks bookings become live. We have carried out work to reduce booking the data that is being downloaded from the database to customers to speed up the experience.

Introduction of Barcode scanners as part of a development of customer experience. Customers will be able to access their membership barcode on the mobile app, no longer requiring the need for a membership card. This will also be utilised within the access gate in the new Allander facility.

#### 2.5.1 Leisuredrome

# Wetside - Public Swimming, Health Suite and Club Swimming (Excludes Swimming Development)

Swimming and usage of the Health Suite continues to demonstrate good attendance figures and is our performing pre pandemic headcounts. This is impressive given the number of times the Leisuredrome pools' access has been restricted due to lack of lifeguards. The flume remained closed during periods 7 - 9.

#### Outdoor Football

Q3 evidenced another consistent usage of the four pitches at the Leisuredrome. The four five a side courts continue to be well used at the Leisuredrome. Although casual bookings is less than previous years the Centre has secured more club bookings than ever before. This is highlighted in the younger age groups around 8 years and younger. Pitches 3 & 4 require to be re-surfaced as both pitches are beyond their useful life.

#### Staffing

Staffing continues to be a real challenge at the Leisuredrome. Recruitment for Leisure Assistants is difficult with very few NPLQ courses being held since the restrictions were eased. The Centre is currently operating with 8 Leisure Assistant FTE vacancies. Requiring us to draw on the supply pool of workers to cover shifts. The Centre team have worked extremely hard just to maintain public access to the pools and there was no full pool closures during Q3 but there was a number of times that access to three pools was reduced to either one or two. In partnership with Kelvin College and West of Scotland

College we have put on an NPLQ course December 2022 to January 2023 and intend to interview all successful participants.

#### Facilities

- The gym upgrading continued with the redecoration of the area week commencing 19 December 2022.
- The balance tank for the leisure pool was disinfected and cleaned with the use of sub-contractors.
- An annual inspection of the flume was carried out in December and the ROSPA inspection of the Soft Play was completed in November 2022 without any major concerns.
- Groundwater investigation is ongoing in the Leisuredrome plant room.
- One of the three boilers failed in December 2022 and costs are being sought to either replace or repair the unit.

## Membership

EDLC DD membership has been boosted by the gym Free Access Scheme for Secondary School pupils. This is reflected at the Leisuredrome with a growth from period 6 to period 9 from 1754 to 2173 (419).

Black Friday campaign resulted in 103 new joiners and 9 upgrades across the three Centres. This was a worthwhile campaign with more marketing scheduled in January 2023 with the new Allander opening soon. Period 9 membership income includes over £8,000 worth of the free access scheme that will be charged back to EDC.

## 2.5.2 Huntershill Sports Hub

### Headcounts

Q3 shows that HSH remains busy with headcounts slightly less than last year primarily due to the drop off in tennis bookings. Adverse weather conditions at the end of period 9 led to a number of pitch and track cancellations.

## 2.5.3 Allander Leisure Centre

The Gym and Swim direct debits have gradually grown over the first 2 Quarters of the year and due to East Dunbartonshire Councils Free Gym & Swim promotion membership has significantly increased. The numbers of 12 - 17 year olds that have joined the Gym has more than doubled across all sites. (Period 7 620 – Period 9 1,416) It is hoped that there is a continuation of this initiative or that EDLC considers offering cheap memberships to hold onto the vast numbers of juniors that have joined.

#### Maintenance

There continues to be significant maintenance issues heat within the Main Hall fell to 6 degrees Celsius during a cold spell in December. All main hall bookings were cancelled for 5 days until there was an improvement in the weather and heat could be returned to the hall. Radiant panels in the ceiling were unable to cope with the outside air temp.

The sewage pumps are no longer viable to be repaired and the sewage pit continues to be pumped out every 3 weeks.

#### Gas Supply

We were advised at short notice that the building would have to close for 3 days in December due to gas pipe issues on the approach to the Allander. All staff were programmed to be redeployed but within a few days of the redeployment the gas redirection was cancelled. Staff were not redeployed and all cancelled activities and the majority of bookings were all reinstated on the system.

Instructor holidays and lack of group fitness instructors (a nationwide issue) has made it extremely difficult to provide a continuous service without cancellations.

The introduction of an automated SMS message to those booked into classes has assisted with our ability to inform customers of any changes to their booked classes more effectively.

Headcount has increased since last year but the usage has been hampered by the reduced car parking and the building site setting that the car park presents. Group Fitness Classes during Q3 has continued to be challenging to provide the required level of service due to the lack of instructors but also the staggering of classes to allow for cars to leave the car park.

Pickleball continues to grow in popularity and we are working with Pickleball Scotland to bring the Scottish age groups competition to the centre.

Swimming Headcount has steadily increased from the previous year.

Recruitment continues to be an issue with limited numbers applying for posts. Lifeguarding posts continue to be difficult to fill. There has been some initial discussions to provide NPLQ training on the job, rather than it be an essential for the post.




