

## Swimming Development Terms and Conditions of booking Holiday Programmes

#### **HOW TO BOOK:**

- Please call 0141 578 8445 once bookings are open to apply. If we are unavailable to take your call please leave only one message.
- Our return call will come from an 0300 number so please do not dismiss this as a marketing call.
- Bookings are dealt with on a 'first come, first served' basis.
- Children will only be allowed to attend within any stated age range or the stated requirements.
- Any child unable to meet the minimum ability / criteria for a class will be removed, no refund will be offered. If you are unsure as to your child's ability please contact Swimming Development.

#### **PAYMENT INSTRUCTIONS:**

- Payment must be made within 48 hours of your booking or the place will be cancelled.
- You can pay in person at reception where your lesson will take place or by telephone.
  Unfortunately Swimming Development are currently unable to take payment.
- Failure to pay by the due dates will result in the loss of your place. You will not receive any reminder to pay and you will be turned away from the class.
- Refunds will only be given if the activity is cancelled by Swimming Development.

### **Publicity:**

During the activity your child may be filmed or photographed for either skills analysis by coaches, or for publicity, either printed, electronic, website or archival reasons.
